# TERMS & CONDITIONS: Park&Walk Grants Program

## As @ 15 June 2015

These Terms and Conditions apply to the 2015 *Park&Walk* Grants Program (Grant Funding) that is being administered by Victoria Walks, with the support of the Victorian Health Promotion Foundation (VicHealth).

By submitting an Application for a *Park&Walk* grant, You agree to be bound by these Terms and Conditions. In the event of any conflict between any terms referred to in any promotional and/or marketing materials and these Terms and Conditions, these Terms and Conditions take precedence.

#### Parties

Victoria Walks (ABN: 884 1942 0305) of Level 7, 225 Bourke Street, Melbourne 3000 ("Victoria Walks") is the administrator of this Funding Agreement. The party identified as the "Funding Recipient" in Schedule 1 is referred to as "You" and "Your".

## The Grant Funding And Eligibility Requirements

1. The Grant Funding is administered by Victoria Walks in accordance with these Terms and Conditions.

2. Applications for Grant Funding can be lodged from Monday 15 June to Friday 24 July 2015, and all Applications must be received by Victoria Walks by 5:00pm Eastern Standard Time on the closing date of 24 July 2015.

3. Details of the Grant Funding and all relevant forms are available on the Victoria Walks website at <u>www.victoriawalks.org.au</u> By participating in this Grant Funding, You agree to act in accordance with:

- a) These Terms and Conditions; and
- b) The <u>Terms and Conditions</u> of the Victoria Walks website.

## **Eligibility to apply for Funding**

4. Victoria Walks provides Funding to Victorian local councils to undertake the following:

a) Engage with primary schools in Your municipality to identify appropriate *Park&Walk* Projects that can alleviate the distance barrier and encourage walking opportunities for students who live more than 2km from the school gate and who demonstrate low walk-to-school behaviour;

b) Design and implement physical infrastructure and/or environmental improvements for primary school students in the funded target group (i.e. who live more than 2km from the school gate and who demonstrate low walk-to-school behaviour) that generate opportunities to walk between 500 metres to one kilometre on a frequent basis to or from school;

c) Deliver local initiatives that fit within the parameters of the *Park&Walk* Program to support ongoing active travel by primary school-aged children in the funded target group.

5. More information about the Grant Funding objectives and Assessment Criteria can be found in the <u>Funding</u> <u>Guidelines</u>.

- 6. Victoria Walks will not Fund an organisation if:
  - a) the organisation operates outside Victoria; and
  - b) the organisation is not classified as a Local Government Authority; and
  - c) the organisation is a recipient of financial support from tobacco companies.

#### **Submitting an Application**

7. To participate in the Grant Funding, You must complete the online Application Form which can be found and downloaded at <u>www.victoriawalks.org.au/ParkAndWalk</u>. You may participate in the Grant Funding application process at any time between Monday 15 June 2015 and the closing date at 17:00 hours Eastern Standard Time on Friday 24 July 2015. Late entries will not be accepted.

8. Victoria Walks will not accept Application by email, post or any other method that does not involve the completion and submission of an online Application Form in accordance with Clause 7 above.

9. By submitting an Application, You warrant that You are an authorised representative with the authority to bind Your organisation to these Terms and Conditions.

10. As part of the Application, You are required to provide Victoria Walks with Your ABN and GST registration status. You are required to notify Victoria Walks if Your GST status changes at any stage of the Grant Funding.

11. As part of the Application process, You are required to provide Victoria Walks with complete and accurate organisation bank details to enable Victoria Walks to transfer Funds to You if You are a Successful Organisation. In the event that You provide incorrect bank account details, You must notify Victoria Walks immediately and provide Your correct bank account details. Where Victoria Walks has relied on the information submitted by You (including in the Application) and transferred Funds to an incorrect bank account, Victoria Walks may attempt to recover the Funds from the receiving financial institution and if successful, Victoria Walks may deduct any costs it incurs as a result of recovering the Funds from the Funding amount awarded to You. You acknowledge that Victoria Walks is not liable to repay any Funds to You in the event that You fail to provide correct bank account details and Victoria Walks is unable to recover the Funds post transfer.

12. You agree to pay Your own costs in relation to Your Application, including but not limited by:

- a) completing Your Application Form and any other associated documents;
- b) complying with these Terms and Conditions and Funding Guidelines; and
- c) attending to any other matter in relation to Your Application.

## Assessment of Applications

- 13. All valid Applications will be assessed by Victoria Walks starting the week beginning Monday 27 July 2015.
- 14. Victoria Walks will:
  - a) assess all Applications and other Submissions against the Assessment Criteria; and
  - b) in its sole discretion, select the Successful Applications.
- 15. In assessing the Applications, Victoria Walks may:
  - a) consider any Application, including any Submission, or any other matter; and
  - b) place any weight on the Assessment Criteria as it sees fit.

#### Assessment Criteria

16. The assessment of Applications (including any Submission) will be made against the following Assessment Criteria:

- a) An innovative response to the *Park&Walk* grants program that delivers physical infrastructure and/or environmental improvements for identified primary schools that have a significant number of students who exhibit low walk-to-school behaviour and who live more than 2km from the school gate. Council improvements will reduce barriers to active travel and provide safe opportunities for these students to walk between 500 metres to one kilometre to or from school on a frequent basis each week.
- b) Through the design and implementation of one or more *Park&Walk* Projects, your council can demonstrate its engagement with identified primary schools where distance to school, traffic and pedestrian safety as well as local walkability have been ongoing issues and which a *Park&Walk* Project could alleviate.
- c) Your council has a demonstrated commitment to active travel and is able to articulate the relevance of your *Park&Walk* Project proposal to the needs of the identified primary school communities in your municipality.
- d) Your council has the capacity and readiness to create one or more *Park&Walk* Projects that will be delivered on time and within budget. If possible, your proposed *Park&Walk* Project can promote VicHealth's *Walk to School* campaign and other active travel initiatives as part of the engagement strategy with the school community.
- e) By committing to a collaboration with Victoria Walks to establish a robust evaluation methodology, your council is willing to actively participate in designing the evaluation framework, the data collection and data analysis in order to gather evidence that can test the effectiveness of the *Park&Walk* initiative.

- f) Your council is willing to share and disseminate the lessons of implementing *Park&Walk* Projects. In addition, if your proposed project lends itself to further research, your council will consider participating in a Randomised Control Trial proposal from VicHealth.
- g) The level of financial and/or in-kind support your council can bring to the project.

17. In addition, the following components of each Application (including any Submission) will be considered as part of the assessment process:

a) <u>Relevance</u>: whether the Application explains council's position to design and deliver *Park&Walk* initiatives that specifically respond to the local community, environment and issues of that council.

b) <u>Equity</u>: whether the Application provides evidence of initiatives that cater for primary school students and their families in the funded target group who, through the provision of *Park&Walk* Projects, are more likely to walk part-way to or from school because the barrier of distance has been addressed in relation to walkability options.

c) <u>Learnings and Growth</u>: whether the Application demonstrates the council's willingness to participate in a collaborative approach to developing an evaluation methodology that tests the efficacy of *Park&Walk* Projects on walking behaviour for primary school students and their families in the funded target group. In addition, councils that have documented the lessons of participating in the *Park&Walk* Program will share this information with Victoria Walks and VicHealth, and other organisations as deemed appropriate by the council, Victoria Walks and/or VicHealth.

18. You acknowledge and accept that Victoria Walks may allocate different weightings to this Assessment Criteria in its assessment of Applications and any decision to do so is at the sole discretion of Victoria Walks.

## Announcement of Successful Organisations

19. Victoria Walks will notify the successful council(s) via the email address provided by You in the *Park&Walk* Application Form by Friday 7 August 2015.

20. Any decision by Victoria Walks to select a successful council or the amount of Funding to be provided to a successful organisation will be at the sole discretion of Victoria Walks.

## Provision of Funding to Successful Organisation(s)

21. If You are a successful organisation, Victoria Walks will provide You with Funds to be used towards the Grant Funding in accordance with these Terms and Conditions.

22. Victoria Walks is not under any obligation to provide any successful organisations with *Park&Walk* Funds until the signing of the funding contract by You that must be returned to Victoria Walks prior to release of funds.

23. The award of the Funding may be subject to additional terms and conditions that Victoria Walks may specify in the contractual agreement.

24. Payment of the Funds shall be made electronically to the successful grant recipients' nominated bank account as specified in the *Park&Walk* Application Form.

25. Victoria Walks will issue successful grant recipients with a Recipient Created Tax Invoice (RCTI) in relation to the Funding. Your council is not required to issue Victoria Walks with any invoices in relation to the Funding.

26. The Funding must be expended by You only for the purposes of carrying out the Grant Funding in accordance with these Terms and Conditions. If, at any time there remains an amount of the Funding that has not been expended in accordance with these Terms and Conditions to Victoria Walks' satisfaction, Victoria Walks may request that You refund all or part of the Funding, as directed by Victoria Walks.

27. You must notify Victoria Walks of any unspent Funds as soon as practicable following the completion of the Grant Funding. At its discretion, Victoria Walks may request the return of the unspent Funds, which You must return to Victoria Walks within 30 days of that request.

#### Victoria Walks' Decisions Are Final

28. For the avoidance of doubt, any decision by Victoria Walks on any matter in relation to the Grant Funding is final and is not subject to review. This includes a decision by Victoria Walks to:

a) Accept an Application;

b) Determine which organisation will be a successful organisation or the number of successful organisations; and

c) Determine the amount of any Funding.

29. You acknowledge and agree that Victoria Walks is under no obligation to discuss or provide feedback to You in relation to an Application or other information You have submitted related to the 2015 *Park&Walk* Grants Program.

30. You also acknowledge and accept that Victoria Walks may not enter in to any correspondence with You unless Your Application is successful.

#### **Financial Records and Reports**

31. You must keep full and accurate Records in relation to the Grant Funding, including, but not limited to, the receipt and expenditure of the Funds, the creation of Submissions and otherwise as required by law. You must retain such Records for a period of at least 7 years following the completion of the Grant Funding.

32. Within 30 days of completion of the Grant Funding, You must complete and return a Certified Financial Acquittal relating to the expenditure of the Funds. Certified Financial Acquittals must identify the Funds provided to You for the Grant Funding and the balance of the Funds on completion of the Grant Funding. The form and structure of the Certified Financial Acquittal will be provided to You by Victoria Walks.

33. Each Certified Financial Acquittal must be signed by a person in senior management authorised to sign financial documents for Your organisation who must certify that:

- a) the statement is a true and fair representation of transactions relating to the Funds;
- b) the Funds were received and expended solely for the purposes of the Grant Making; and
- c) these Terms and Conditions have been complied with.

34. Victoria Walks may undertake an evaluation of the Grant Making at any time. You must allow Victoria Walks and its auditor's access to Your Records, Your premises and any other information Victoria Walks may require in order to allow Victoria Walks to audit Your performance of Your obligations under these Terms and Conditions. For the avoidance of doubt, each party will bear its own costs of conducting or participating in an audit under Clause 34.

35. If an audit under Clause 34 reveals that You have failed to comply with any of Your obligations under these Terms and Conditions, You must immediately take such actions as necessary to promptly remedy such non-compliance. You must comply with any reasonable directions or instructions from Victoria Walks as to the manner (including timing) in which such non-compliance must be remedied.

36. At Victoria Walks' request, You must - at Your own cost - cooperate with and assist Victoria Walks in connection with:

(a) any enquiry or investigation by a government authority, including the Auditor-General; and(b) any request made to Victoria Walks concerning the Grant Making or the Funding under the Freedom of

Information Act 1982 (Vic).

#### **Change of Contact Information**

37. If there is a change to any contact information, You must notify Victoria Walks as soon as practicable following that change and give Victoria Walks the relevant details of that change.

#### **Tobacco Products and Promotion**

38. You acknowledge that VicHealth has contracted Victoria Walks to administer the *Park&Walk* Grants Program and that VicHealth is established under the Tobacco Act 1987 (Vic) and has certain objectives and functions set by that Act.

39. You will not endorse, promote, sponsor or otherwise be affiliated with tobacco, smoking or tobacco related products in relation to any activity that You undertake in connection with the Grant Funding.

40. You must not receive any funding, sponsorship or any other kind of endorsement from any person or organisation involved in or affiliated with the production, manufacture or marketing of tobacco, smoking or tobacco related products.

## Acknowledgement of Victoria Walks and VicHealth

41. You must acknowledge Victoria Walks and VicHealth's contribution of Funding to the Grant Funding:

a) in all public announcements concerning that Grant Funding or the outcomes of that Grant Funding;
b) in all documents, materials, reports and other items relating to that Grant Funding or the outcomes of that Grant Funding;

c) at all events (including any lectures) relating to or organised in connection with that Grant Funding; and d) as otherwise directed by Victoria Walks and/or VicHealth.

42. You must:

d) be willing to display Victoria Walks and VicHealth's promotional materials at all events and activities relating to the Grant Funding; and

e) include a written acknowledgement of the Funding by Victoria Walks and VicHealth, along with the Victoria Walks branding and VicHealth Trade Marks in all publications, newsletters and other materials relating to the Grant Funding, as directed by Victoria Walks and/or VicHealth.

43. Victoria Walks and VicHealth grants You a non-exclusive, non-transferable, royalty-free licence to use the Victoria Walks branding and VicHealth Trade Marks for the purpose of acknowledging Victoria Walks and VicHealth's provision of Funding in accordance with clause

44. Victoria Walks and VicHealth may, from time to time, provide You with guidelines as to how We wish the Victoria Walks branding and/or VicHealth Trade Marks to be used and You must comply with those guidelines.

45. You must not:

e) use the Victoria Walks branding and VicHealth Trade Marks other than to acknowledge Victoria Walks and VicHealth's contribution to the Grant Funding or as otherwise agreed by Victoria Walks and/or VicHealth in writing;

f) authorise any other party to use the Victoria Walks branding and VicHealth Trade Marks without Victoria Walks' and/or VicHealth's prior written consent;

g) use any of the Victoria Walks branding and VicHealth Trade Marks or any substantially identical or deceptively similar mark as part of any corporate or business name without Victoria Walks' and/or VicHealth's prior written consent;

h) do any of the things specified in section 26(1) of the *Trade Marks Act 1995 (Cth)*, except as expressly permitted under these Terms and Conditions or with the prior written consent of Victoria Walks and/or VicHealth.

46. You must only use the Victoria Walks branding and VicHealth Trade Marks in a manner that enhances Victoria Walks and VicHealth's credibility and reputation.

#### **Warranties**

47. By participating in this Grant Funding, You represent and warrant that:

a) You have obtained all rights, licences, and permissions necessary, in writing, from any person who may have helped create Your Application and any Submissions submitted as part of this Grant Funding; and b) Your Application and any Submissions lodged with Victoria Walks as part of this Grant Funding complies with these Terms and Conditions (and any applicable third party terms and conditions), and:

i. is Your original work;

ii. has not previously been submitted in any third party promotion, competition or event;
iii. does not contain any use of the names, likenesses, photographs, or other identifying elements, in whole or in part, of any person, living or dead, without permission of the relevant person or their parent or legal guardian using the relevant consent form available on the Victoria Walks Website;
iv. does not include trademarks, logos, or copyright protected material which belong to third parties unless You have permission from the owner to use the same in Your entry (including, but not limited to company names, music, photographs, motion picture or television programme clips or audio tracks, works of art, or images published on or in websites, television, movies, or other media);
v. is not subject to any third party agreements, and Victoria Walks and VicHealth will not be required to pay any licence fees, royalties or other sums to any person or entity as a result of using the Application and/or any Submissions in accordance with these Terms and Conditions;
vi. does not defame, misrepresent, or contain disparaging remarks or any other content which could

adversely affect the name, reputation or goodwill of Victoria Walks and VicHealth or any other individuals and/or entities, the determination of which shall remain in the sole discretion of Victoria Walks and VicHealth;

vii. does not contain pornographic or sexual content, hateful or offensive content, content which promotes violence or harm to another living creature or any other offensive, obscene or inappropriate content, the determination of which shall remain in the sole discretion of Victoria Walks and VicHealth;

viii. does not include threats of any kind or that intimidate, harass or bully anyone, or invade the privacy of any person, the determination of which shall remain in the sole discretion of Victoria Walks and VicHealth;

ix. does not violate any applicable laws or include any content that may encourage or provide instructions for a criminal offence;

x. does not feature, refer to, or mention any brands competing with of Victoria Walks and VicHealth; and

xi. along with any electronic method of communication used to submit information to Victoria Walks and VicHealth, does not contain any known virus, trojan horse, worm, trapdoor or similar software that may in any way infect or affect any of Victoria Walks and VicHealth (or a third party's) hardware or software systems.

#### **Right to remove or reject organisations**

48. Victoria Walks reserves the right to remove or reject from the Grant Funding any organisation that has entered into the Grant Funding process if:

a) Victoria Walks decides not to select the organisation's Application following an assessment of the Application against the Assessment Criteria;

b) the organisation's Submission is illegible, incomplete or fraudulent or does not comply with these Terms and Conditions;

c) the organisation has breached these Terms and Conditions or Victoria Walks suspects that the organisation has breached these Terms and Conditions;

d) Victoria Walks receives a complaint about the organisation from a third party in relation to a Submission or any matter relating to this Grant Funding;

e) the organisation has tampered with the operation of the Submission , has engaged in cheating, hacking, deception or any other unfair practices such as intending to annoy, abuse, threaten or harass any other

organisations or Victoria Walks and/or any of its agents or representatives, or Victoria Walks suspects, on reasonable grounds, that the organisation has done so;

f) the organisation submitting the Application does any act or does anything that is contrary to prevailing community standards, or is otherwise regarded by the public as unacceptable; org) Victoria Walks otherwise thinks it is appropriate to do so.

## **Intellectual Property**

49. Subject to Clauses 49 to 51, You will retain all copyright and any other intellectual property rights in the Submission.

50. By submitting any Application or other Submission as part of the Grant Funding, You grant to Victoria Walks and VicHealth a worldwide, exclusive, transferable, royalty-free, perpetual, irrevocable license (including a right to sublicense) to use, reproduce, distribute, adapt (including without limitation edit, modify, translate and reformat), derive, transmit, publish, communicate, display and perform (publicly or otherwise), the Submission for the purpose of evaluating the Submission, and for Victoria Walks' and VicHealth's marketing, advertising and/or promotional activities, which may include, but is not limited to, using, publishing or communicating the Submission on a website, social media or other digital media.

51. You hereby represent and warrant that You have all permissions necessary to grant the rights provided for in Clause 49 and that any use of such Submissions by, or on behalf of, Victoria Walks and VicHealth shall comply with all applicable laws, rules, and regulations and not infringe or otherwise violate the intellectual property, moral rights or other rights of any third party.

52. By participating in the Grant Funding, You accept and agree that you waive any moral rights you may have in relation to any Submission you submit, and that Victoria Walks and VicHealth may use any names, photographs or video footage featured in the Submission in its publicity materials without any obligation for Victoria Walks and VicHealth to provide acknowledgment, payment or other compensation to You. This includes making such names and photographs available for internal business purposes, on the Victoria Walks and VicHealth Websites, the Funding Webpages and other advertising and promotional materials.

#### **Confidentiality**

53. Confidential Information disclosed by Victoria Walks and/or VicHealth to You during the Grant Funding must only be used for the express purpose for which it was disclosed. You agree to keep in strict confidence all technical or commercial know-how, specifications, inventions, processes or programs which are of a confidential nature and have been disclosed by Victoria Walks and/or VicHealth to You. You must not, without the prior written consent of Victoria Walks and/or VicHealth, use or disclose the Confidential Information, or permit such Confidential Information to be used or disclosed by any third party, except:

a) where it is necessary for the purposes of the project and has been checked with Victoria Walks;

b) where You have obtained the prior written permission from Victoria Walks and/or VicHealth;

c) to Your officer's agents, professional advisers, employees, contractors and insurers, subject to those persons first being bound by confidentiality obligations in relation to that Confidential Information.

#### **Privacy**

54. In administering this Grant Funding, Victoria Walks will collect personal information, including without limitation, the names and contact details of persons applying for a Grant Funding.

55. Any personal information collected by Victoria Walks in administering the Grant Funding will be managed in accordance with the *Information Privacy Principles (IPPs)*, the *Privacy and Data Protection Act 2014 (Vic)* and Victoria Walks' <u>Privacy Statement</u>.

56. You acknowledge and accept that personal information will be shared with Victoria Walks and/or VicHealth's employees, agents and sub-contractors to the extent necessary for the Grant Funding to be delivered and for Victoria Walks' and VicHealth's promotional purposes.

#### **Consent Forms**

57. If You are a successful organisation, You must obtain:

a) Privacy and moral rights consents from all individuals appearing in photographs and/or video footage provided, or their parents or legal guardians (where applicable); and

b) A copyright licence from all individuals or legal entities contributing intellectual property to Your photograph and/or video footage.

58. In obtaining such consents or licences, you must use the relevant consent forms appearing on the Victoria Walks website and provide the signed consent forms upon receiving notification that Your Application is a Successful Application. Victoria Walks and VicHealth will require You to return the completed <u>consent forms</u>.

#### Indemnity

59. By participating in this Grant Funding, You will indemnify and hold Victoria Walks and VicHealth and its officers, employees and agents harmless against any loss, liability, or injury arising out of, or in connection with, this Grant Funding including without limitation:

a) any breach of these Terms and Conditions and the Terms and Conditions on the Victoria Walks Website;

- b) any warranty given by You under these Terms and Conditions being incorrect or misleading in any way;
- c) any breach of confidentiality or breach of privacy by You;
- d) any infringement of a third party's intellectual property rights;
- e) any defamatory statement;
- f) any unlawful activity;
- g) any negligent act or failure to act by You; and
- h) anything else which causes loss, liability, or injury.

61. You shall for the duration of the Grant Funding, and for 7 years following completion of the Grant Funding, maintain public liability insurance of at least \$10,000,000 per event from a reputable insurer (when applicable).

#### Modification, Cancellation or Suspension of this Funding

62. Victoria Walks reserves the right, at any time and in its sole discretion, to:

- a) alter the structure and/or timing of the Grant Funding;
- b) vary or extend any time or date specified in these Terms and Conditions;
- c) require additional information or clarification from an organisation submitting an Application;
- d) modify, cancel, terminate or suspend this Grant Funding in whole or in part; and
- e) will not be liable for any costs or expenses incurred by You or any other person as a result of exercising any of its rights in accordance with this Clause.

63. If Victoria Walks exercises any of its rights outlined in clause 54, Victoria Walks will notify You in writing.

#### **Disclaimer**

64. Victoria Walks is not responsible and disclaims all liability for any condition, circumstances, losses, failures or delays caused by events beyond its control.

65. To the maximum extent permitted by law, Victoria Walks and its officers, employees and agents assume no responsibility for any damage, loss, costs, expenses (including special, indirect or consequential losses, or loss of profits) arising out of, or in connection with, this Grant Funding including without limitation to:

- a) any technical, hardware or software failures, lost, faulty or unavailable network connections or difficulties of any kind that may limit or prohibit your ability to participate in the Grant Funding;
- b) any lost, damaged, defaced, incomplete, illegible or otherwise unreadable Submission;

c) any unauthorised access to, or theft, destruction or alteration of any Submission at any point in the operation of this Grant Funding;

d) any infringement of third party's intellectual property rights, breach of confidentiality or breach of privacy or other action which arises as a result of:

i. Your Submission; or

ii. Victoria Walks and/or VicHealth's use or disclosure of a Submission in accordance with these Terms and Conditions; or

iii. any defamatory statement; or

iv. any unlawful activity by any person; or

v. any breach by You of any third party terms and conditions; or

vi. any breach of these Terms and Conditions by You or any misleading warranty provided by You; or vii. anything else which causes loss, liability, or injury.

66. By participating in this Grant Funding, You voluntarily and knowingly release, discharge and relinquish any and all claims, actions and lawsuits of any kind against Victoria Walks and VicHealth and agree that no claim relating to any loss or injury arising as a result of any of the above shall be made against Victoria Walks and VicHealth.

## **Governing Law**

67. These Terms and Conditions are governed by, and are to be construed in accordance with, the laws applicable in Victoria and You irrevocably and unconditionally submit to the non-exclusive jurisdiction of the courts of Victoria. You waive any right to object to any proceedings being brought in those courts.

## **Definitions**

"Application" means an application made by a Victorian council to secure a *Park&Walk* Grant from Victoria Walks; "Assessment Criteria" means the selection criteria set out in clauses 16, 17, and 18;

"Award and Acceptance Email" means the notification and award of a Grant to Successful Organisation/s;

"Certified Financial Acquittal" means a financial statement provided by Victoria Walks to Successful Organisations in accordance with clauses 32 and 33;
